





AN ACT RENAMING THE MONTEVISTA-CATEEL NATIONAL  
HIGHWAY TRAVERSING THE MUNICIPALITY OF  
COMPOSTELA, COMPOSTELA VALLEY PROVINCE INTO THE  
BENIGNO S. AQUINO JR. NATIONAL HIGHWAY

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1       SECTION 1. The Montevista-Cateel National Highway traversing the  
2       Municipality of Compostela, Compostela Valley Province is hereby renamed  
3       Benigno S. Aquino Jr. National Highway.

4       SEC. 2. The Department of Public Works and Highways shall place  
5       appropriate markers along the Benigno S. Aquino Jr. National Highway and  
6       shall issue the necessary rules, orders and circulars to implement this Act.

7       SEC. 3. This Act shall take effect fifteen (15) days after its publication  
8       in two (2) national newspapers of general circulation.
