AN ACT RENAMING THE KAY TIKLING-ANTIPOLO-TERESA-MORONG NATIONAL ROAD IN THE PROVINCE OF RIZAL, TRAVERSING THROUGH BARANGAY DOLORES IN THE MUNICIPALITY OF TAYTAY UP TO BARANGAY MAYBANCAL IN THE MUNICIPALITY OF MORONG, AS CORAZON C. AQUINO AVENUE

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. In recognition of her public service rendered to the people
2 as the 11th President of the Republic of the Philippines, and of her legacy in
3 the restoration of political democracy and constitutional rule in the country,
4 the Kay Tikling-Antipolo-Teresa-Morong National Road in the Province of
5 Rizal, traversing Barangay Dolores in the Municipality of Taytay up to
6 Barangay Maybancal in the Municipality of Morong, is hereby renamed
7 Corazon C. Aquino Avenue.

8 SEC. 2. The Department of Public Works and Highways shall place
9 appropriate markers along the Kay Tikling-Antipolo-Teresa-Morong National
10 Road in the Province of Rizal and shall issue the necessary orders and
11 circulars to implement the provisions of this Act.

1 SEC. 3. This Act shall take effect fifteen (15) days after its complete
2 publication in the *Official Gazette* or in at least two (2) newspapers of general
3 circulation.
