Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. The intersection of Jose Abad Santos Avenue (formerly
- 2 the Gapan-San Fernando-Olongapo Road) and the Guagua-Floridablanca
- 3 Provincial Road located at the border of Barangay San Antonio and Barangay
- 4 Jose Abad Santos, both in the Municipality of Guagua, Province of Pampanga
- 5 is hereby named the "William Golangeo Junction".
- SEC. 2. The Department of Public Works and Highways shall issue the
- 7 necessary rules, orders and circulars to implement the provision of this Act.
- SEC, 3. This Act shall take effect fifteen (15) days after its publication
- 9 in the Official Gazette or in a newspaper of general circulation.
