Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The intersection of Jose Abad Santos Avenue (formerly
2 the Gapan-San Fernando-Olongapo Road) and the Guagua-Floridablanca
3 Provincial Road located at the border of Barangay San Antonio and Barangay
4 Jose Abad Santos, both in the Municipality of Guagua, Province of Pampanga
5 is hereby named the "William Golangco Junction".

6 SEC. 2. The Department of Public Works and Highways shall issue the
7 necessary rules, orders and circulars to implement the provision of this Act.

8 SEC. 3. This Act shall take effect fifteen (15) days after its publication
9 in the *Official Gazette* or in a newspaper of general circulation.
