Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. The Kalbay National High School Annex in
- 2 Barangay Sugal, Municipality of Jose Abad Santos, Province of
- 3 Davao Occidental is hereby separated from the Kalbay National
- 4 High School, and converted into an independent national high
- 5 school to be known as Emeliano S. Fontanares Sr. National High
- 6 School.
- 7 SEC. 2. All personnel, assets, liabilities, and records of the
- 8 Kalbay National High School Annex are hereby transferred to and
- 9 absorbed by the Emeliano S. Fontanares Sr. National High School.
- 10 SEC. 3. The Secretary of Education shall immediately include
- 11 in the Department's program the operationalization of the

- 4 Thereafter, the amount necessary for the continued operation of the
- 5 school shall be included in the annual General Appropriations Act.
- SEC. 4. The Secretary of Education shall formulate the rules and regulations necessary to carry out the purpose of this Act within

8 one hundred twenty (120) days after its effectivity.

SEC. 5. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
