AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN
BARANGAY PAN-AY DAKO, MUNICIPALITY OF CLARIN,
PROVINCE OF MISAMIS OCCIDENTAL TO BE KNOWN
AS FELINA SEVILLA OAMINAL NATIONAL HIGH
SCHOOL, AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established, under the supervision
2 of the Department of Education, a national high school in Barangay
3 Pan-ay Dako, Municipality of Clarin, Province of Misamis
4 Occidental to be known as Felina Sevilla Oaminal National High
5 School.

6 SEC. 2. The Secretary of Education shall immediately include
7 in the Department's program the operationalization of the Felina
8 Sevilla Oaminal National High School, the funding of which shall be
9 included in the annual General Appropriations Act.

1 SEC. 3. The Secretary of Education shall formulate the rules
2 and regulations implementing the provisions of this Act within one
3 hundred twenty (120) days after its effectivity.

4 SEC. 4. This Act shall take effect fifteen (15) days after its
5 publication in the *Official Gazette* or in a newspaper of general
6 circulation.
