## HOUSE OF REPRESENTATIVES

#### H. No. 6918

By Representatives Oaminal, Durano and Nograles (K.A.), per Committee Report No. 559

AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY PAN-AY DAKO, MUNICIPALITY OF CLARIN, PROVINCE OF MISAMIS OCCIDENTAL TO BE KNOWN AS FELINA SEVILLA OAMINAL NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 Section 1. There is hereby established, under the supervision

2 of the Department of Education, a national high school in Barangay

3 Pan-ay Dako, Municipality of Clarin, Province of Misamis

Occidental to be known as Felina Sevilla Oaminal National High

SEC. 2. The Secretary of Education shall immediately include

in the Department's program the operationalization of the Felina

Sevilla Oaminal National High School, the funding of which shall be

included in the annual General Appropriations Act.

SEC. 3. The Secretary of Education shall formulate the rules and regulations implementing the provisions of this Act within one hundred twenty (120) days after its effectivity.

SEC. 4. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
