





AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL
IN BARANGAY TIBLAC, MUNICIPALITY OF AMBAGUIO,
PROVINCE OF NUEVA VIZCAYA TO BE KNOWN
AS TIBLAC NATIONAL HIGH SCHOOL, AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established, under the
2 supervision of the Department of Education, a national high school
3 in Barangay Tiblac, Municipality of Ambaguio, Province of Nueva
4 Vizcaya to be known as Tiblac National High School.

5 SEC. 2. The Secretary of Education shall immediately
6 include in the Department's program the operationalization of the
7 Tiblac National High School, the funding of which shall be included
8 in the annual General Appropriations Act.

9 SEC. 3. The Secretary of Education shall formulate the rules
10 and regulations implementing the provisions of this Act within one
11 hundred twenty (120) days after its effectivity.

1 SEC. 4. This Act shall take effect fifteen (15) days after
2 its publication in the *Official Gazette* or in a newspaper of general
3 circulation.
