AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN
BARANGAY VEINTE REALES, VALENZUELA CITY, TO
BE KNOWN AS VEINTE REALES NATIONAL HIGH
SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established, under the
2 supervision of the Department of Education, a national high
3 school in Barangay Veinte Reales, Valenzuela City, to be known as
4 Veinte Reales National High School.

5 SEC. 2. The Secretary of Education shall immediately
6 include in the Department's program the operationalization of the
7 Veinte Reales National High School, the funding of which shall be
8 included in the annual General Appropriations Act.

9 SEC. 3. The Secretary of Education shall formulate the rules
10 and regulations implementing the provisions of this Act within one
11 hundred twenty (120) days after its effectivity.

1 SEC. 4. This Act shall take effect fifteen (15) days after its
2 publication in the *Official Gazette* or in a newspaper of general
3 circulation.
