AN ACT DECLARING MAY 3 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE MUNICIPALITY OF STA. CRUZ, PROVINCE OF MARINDUQUE, IN COMMEMORATION OF ITS FOUNDING ANNIVERSARY. TO BE KNOWN AS "STA. CRUZ DAY"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. May 3 of every year is hereby declared a special nonworking holiday in the Municipality of Sta. Cruz, Province of Marinduque, to be known as "Sta. Cruz Day", in commemoration of its founding anniversary.

SEC. 2. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
