





AN ACT DECLARING MARCH 21 OF EVERY YEAR A SPECIAL  
NONWORKING HOLIDAY IN THE MUNICIPALITY OF SAN  
FABIAN, PROVINCE OF PANGASINAN, IN COMMEMORATION  
OF ITS FOUNDING ANNIVERSARY

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION I. March 21 of every year is hereby declared a special  
2 nonworking holiday in the Municipality of San Fabian, Province of  
3 Pangasinan, in commemoration of its founding anniversary.

4           SEC. 2. This Act shall take effect fifteen (15) days after its publication  
5 in the *Official Gazette* or in a newspaper of general circulation.
