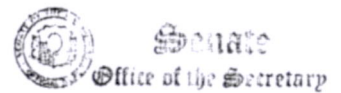





*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. September 11 of every year is hereby declared a special
2 nonworking holiday in the Province of Ilocos Norte in commemoration of the
3 birth anniversary of former President Ferdinand Edralin Marcos, to be known
4 as "President Ferdinand Edralin Marcos Day".

5 SEC. 2. This Act shall take effect fifteen (15) days after its publication
6 in the *Official Gazette* or in a newspaper of general circulation.
