AN ACT DECLARING OCTOBER 28 OF EVERY YEAR A SPECIAL
NONWORKING HOLIDAY IN THE PROVINCE OF DAVAO

ANNIVERSARY

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. October 28 of every year is hereby declared a special
2 nonworking holiday in the Province of Davao Occidental in commemoration
3 of its founding anniversary.

4 SEC. 2. This Act shall take effect fifteen (15) days after its publication
5 in the *Official Gazette* or in a newspaper of general circulation.
