AN ACT DECLARING AUGUST 30 OF EVERY YEAR A SPECIAL  
NONWORKING HOLIDAY IN THE CITY OF MANDAUE,  
PROVINCE OF CEBU, IN COMMEMORATION OF ITS CHARTER  
DAY

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1 SECTION 1. August 30 of every year is hereby declared a special  
2 nonworking holiday in the City of Mandaue, Province of Cebu, in  
3 commemoration of its charter day.

4 SEC. 2. This Act shall take effect fifteen (15) days after its publication  
5 in the *Official Gazette* or in a newspaper of general circulation.
