

AN ACT MOVING THE DATE OF "CATARMAN DAY" TO AUGUST 30  
OF EVERY YEAR, AMENDING FOR THE PURPOSE REPUBLIC  
ACT NO. 9203, ENTITLED "AN ACT DECLARING THE  
FIFTEENTH (15<sup>TH</sup>) DAY OF AUGUST OF EVERY YEAR AS A  
SPECIAL NONWORKING HOLIDAY IN THE MUNICIPALITY OF  
CATARMAN, PROVINCE OF CAMIGUIN, TO BE KNOWN AS  
'CATARMAN DAY' "

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. Section 1 of Republic Act No. 9203 is hereby amended to  
2 read as follows:

3                   "SECTION 1. August [Fifteenth (15<sup>th</sup>)] 30 of every year is  
4 hereby declared [as] a special nonworking holiday in the  
5 Municipality of Catarman, Province of Camiguin, to  
6 commemorate its foundation day anniversary. TO BE KNOWN AS  
7 'CATARMAN DAY'."

8           SEC. 2. The Municipal Government of Catarman in the Province of  
9 Camiguin shall disseminate to its component barangays, as well as to the  
10 Provincial Government of Camiguin, through means it deems proper and

1 expedient, the change of the date of Catarman Day, for proper coordination of  
2 activities.

3 SEC. 3. This Act shall take effect fifteen (15) days after its publication  
4 in the *Official Gazette* or in a newspaper of general circulation.
