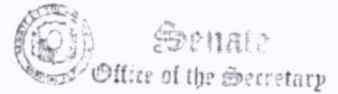





AN ACT DECLARING SEPTEMBER 2 OF EVERY YEAR A SPECIAL
NONWORKING HOLIDAY IN THE PROVINCE OF ALBAY,
INCLUDING THE CITIES THEREIN, IN COMMEMORATION OF
THE BIRTH ANNIVERSARY OF GENERAL SIMEON A. OLA, TO
BE KNOWN AS "SIMEON OLA DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. September 2 of every year is hereby declared a special
2 nonworking holiday in the Province of Albay, including the cities therein, in
3 commemoration of the birth anniversary of General Simeon A. Ola and in
4 recognition of his life, service and bravery, being the last Filipino army
5 general who surrendered to the American forces during the
6 Philippine-American war. The special holiday shall be known as the
7 "Simeon Ola Day".

8 SEC. 2. This Act shall take effect fifteen (15) days after its publication
9 in the *Official Gazette* or in a newspaper of general circulation.
