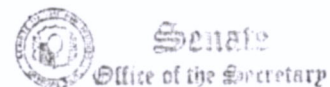





NONWORKING HOLIDAY IN THE PROVINCE OF
PANGASINAN, IN COMMEMORATION OF ITS FOUNDING
ANNIVERSARY, TO BE KNOWN AS THE "PANGASINAN DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. April 5 of every year is hereby declared a special
2 nonworking holiday in the Province of Pangasinan, in commemoration of its
3 founding anniversary, to be known as the "Pangasinan Day".

4 SEC. 2. This Act shall take effect fifteen (15) days after its publication
5 in the *Official Gazette* or in a newspaper of general circulation.
