



AN ACT DECLARING APRIL 21 OF EVERY YEAR A SPECIAL  
NONWORKING HOLIDAY IN THE MUNICIPALITY OF  
ORANI, PROVINCE OF BATAAN, IN COMMEMORATION OF  
ITS FOUNDING ANNIVERSARY, TO BE KNOWN AS  
"ORANI FOUNDATION DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. April 21 of every year is hereby declared a special  
2 nonworking holiday in the Municipality of Orani, Province of Bataan,  
3 in commemoration of its founding anniversary, to be known as  
4 "Orani Foundation Day".

5           SEC. 2. This Act shall take effect fifteen (15) days after its publication  
6 in the *Official Gazette* or in a newspaper of general circulation.
