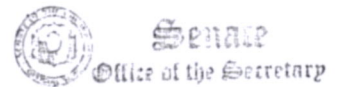



AN ACT DECLARING NOVEMBER 28 OF EVERY YEAR A SPECIAL
NONWORKING HOLIDAY IN THE MUNICIPALITY OF SANTA
MARGARITA, PROVINCE OF SAMAR, IN COMMEMORATION
OF ITS FOUNDING ANNIVERSARY, TO BE KNOWN AS THE
"SANTA MARGARITA FOUNDATION DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. November 28 of every year is hereby declared a special
2 nonworking holiday in the Municipality of Santa Margarita, Province of
3 Samar, in commemoration of its founding anniversary, to be known as
4 the "Santa Margarita Foundation Day". When the holiday falls on a Saturday
5 or a Sunday, the special nonworking day shall be observed on the Monday
6 that follows.

7 SEC. 2. This Act shall take effect fifteen (15) days after its publication
8 in the *Official Gazette* or in a newspaper of general circulation.
