

AN ACT DECLARING OCTOBER 16 OF EVERY YEAR A SPECIAL  
NONWORKING HOLIDAY IN THE CITY OF CALBAYOG,  
PROVINCE OF SAMAR, IN COMMEMORATION OF ITS  
CHARTER DAY ANNIVERSARY, TO BE KNOWN AS THE  
"CALBAYOG CITY CHARTER DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. October 16 of every year is hereby declared a special  
2 nonworking holiday in the City of Calbayog, Province of Samar,  
3 in commemoration of its charter day anniversary, to be known as the  
4 "Calbayog City Charter Day". When the holiday falls on a Saturday or a  
5 Sunday, the special nonworking day shall be observed on the Monday that  
6 follows.

7           SEC. 2. This Act shall take effect fifteen (15) days after its publication  
8 in the *Official Gazette* or in a newspaper of general circulation.
