*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. December 1 of every year is hereby declared a special
2 nonworking holiday in the Municipality of Padre Garcia, Province of
3 Batangas, in commemoration of its founding anniversary and the annual
4 "Kabakahan Festival".

5 SEC. 2. This Act shall take effect fifteen (15) days after its publication
6 in the *Official Gazette* or in a newspaper of general circulation.
