AN ACT DECLARING JANUARY 23 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE PROVINCE OF BULACAN IN COMMEMORATION OF THE INAUGURATION OF THE PHILIPPINE REPUBLIC

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. January 23 of every year is hereby declared a special
2 nonworking holiday in the Province of Bulacan in commemoration of the
3 inauguration of the Philippine Republic.

4 SEC. 2. This Act shall take effect fifteen (15) days after its publication
5 in the *Official Gazette* or in a newspaper of general circulation.
