AN ACT DECLARING MARCH 2 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE PROVINCE OF LA UNION IN COMMEMORATION OF ITS FOUNDING ANNIVERSARY, TO BE KNOWN AS "LA UNION DAY"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. March 2 of every year is hereby declared a special
2 nonworking holiday in the Province of La Union in commemoration of its
3 founding anniversary, to be known as "La Union Day". When the holiday falls
4 on a Saturday or a Sunday, or on a nationally declared nonworking holiday,
5 the special nonworking day shall be observed on the next business day that
6 follows.

7 SEC. 2. This Act shall take effect fifteen (15) days after its publication
8 in the *Official Gazette* or in a newspaper of general circulation.

Approved,
