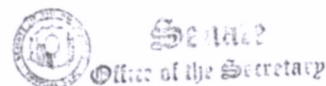





AN ACT DECLARING JANUARY 16 OF EVERY YEAR A SPECIAL
NONWORKING HOLIDAY IN THE CITY OF NAVOTAS IN
COMMEMORATION OF ITS FOUNDING ANNIVERSARY

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. January 16 of every year is hereby declared a special
2 nonworking holiday in the City of Navotas in commemoration of its founding
3 anniversary.

4 SEC. 2. This Act shall take effect fifteen (15) days after its publication
5 in the *Official Gazette* or in a newspaper of general circulation.
