



NONWORKING HOLIDAY IN THE MUNICIPALITY OF
RODRIGUEZ, PROVINCE OF RIZAL, IN COMMEMORATION
OF THE BIRTH ANNIVERSARY OF THE HONORABLE
EULOGIO "AMANG" ADONA RODRIGUEZ, SR.

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. January 21 of every year is hereby declared a special
2 nonworking holiday in the Municipality of Rodriguez, Province of Rizal, in
3 commemoration of the birth anniversary of the Honorable Eulogio "Amang"
4 Adona Rodriguez, Sr., and in recognition of his altruistic acts and contribution
5 to public service.

6 SEC. 2. This Act shall take effect fifteen (15) days after its publication
7 in the *Official Gazette* or in a newspaper of general circulation.
