Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. January 21 of every year is hereby declared a special nonworking holiday in the Municipality of Rodriguez, Province of Rizal, in commemoration of the birth anniversary of the Honorable Eulogio "Amang" Adona Rodriguez, Sr., and in recognition of his altruistic acts and contribution
- SEC. 2. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
