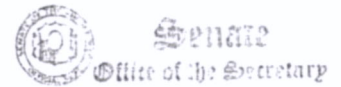





IN COMMEMORATION OF ITS FOUNDING ANNIVERSARY
TO BE KNOWN AS "BATAAN FOUNDATION DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. January 11 of every year is hereby declared a special
2 nonworking holiday in the Province of Bataan in commemoration of its
3 founding anniversary to be known as "Bataan Foundation Day".

4 SEC. 2. This Act shall take effect fifteen (15) days after its publication
5 in the *Official Gazette* or in a newspaper of general circulation.
