Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. June 18 of every year is hereby declared
- 2 a special nonworking holiday in the City of Bacolod, Province of
- 3 Negros Occidental, to be known as the "Bacolod City Charter Day",
- 4 in commemoration of the day President Manuel L. Quezon signed
- 5 and approved into effect Commonwealth Act No. 326, creating
- 6 the City of Bacolod.
- 7 SEC. 2. Republic Act No. 7724, entitled: "An Act Declaring
- 8 October Nineteen Of Every Year A Special Nonworking Public
- 9 Holiday In The City Of Bacolod To Be Known As "Bacolod City

- 1 Charter Day", and any law, presidential decree or issuance,
- 2 executive order, letter of instruction, administrative order, rule
- 3 or regulation contrary to or inconsistent with the provisions of
- 4 this Act are hereby repealed, modified or amended accordingly.
- 5 SEC. 3. This Act shall take effect fifteen (15) days after
- 6 its publication in the Official Gazette or in a newspaper of general
- 7 circulation.
