AN ACT PROVIDING FOR THE RANK CLASSIFICATION
IN THE PHILIPPINE NATIONAL POLICE, AMENDING
FOR THE PURPOSE SECTION 28 OF REPUBLIC ACT
NO. 6975, AS AMENDED, OTHERWISE KNOWN AS THE
"DEPARTMENT OF THE INTERIOR AND LOCAL
GOVERNMENT ACT OF 1990"

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. Section 28 of Republic Act No. 6975, otherwise
2 known as the "Department of the Interior and Local Government
3 Act of 1990", is hereby amended to read as follows:

4 "SEC. 28. *Rank Classification.* - For purposes
5 of CLARITY OF COMMAND AND RESPONSIBILITY, AND
6 FOR THE EFFECTIVE AND efficient administration,
7 supervision and control, the rank classification of the

1 **[members] UNIFORMED PERSONNEL** of the PNP shall
2 be as follows:

3 **"[Director General] POLICE GENERAL**

4 **"[Deputy Director General] POLICE LIEUTENANT**
5 **GENERAL**

6 **"[Director] POLICE MAJOR GENERAL**

7 **"[Chief Superintendent] POLICE BRIGADIER**
8 **GENERAL**

9 **"[Senior Superintendent] POLICE COLONEL**

10 **"[Superintendent] POLICE LIEUTENANT**
11 **COLONEL**

12 **"[Chief Inspector] POLICE MAJOR**

13 **"[Senior Inspector] POLICE CAPTAIN**

14 **"[Inspector] POLICE LIEUTENANT**

15 **"[Senior Police Officer IV] POLICE MASTER**
16 **SERGEANT**

17 **"[Senior Police Officer III] POLICE TECHNICAL**
18 **SERGEANT**

19 **"[Senior Police Officer II] POLICE STAFF**
20 **SERGEANT**

21 **"[Senior Police Officer I] POLICE SERGEANT**

22 **"[Police Officer III] POLICE CORPORAL**

23 **"[Police Officer II] PATROLMAN FIRST CLASS**

24 **"[Police Officer I] PATROLMAN"**

1 SEC. 2. The remaining provisions of Republic Act No. 6975,
2 as amended by Republic Act No. 8551, otherwise known as the
3 "Philippine National Police Reform and Reorganization Act of 1998",
4 that have reference to the rank classification of the uniformed
5 personnel of the Philippine National Police, and all other laws,
6 executive orders, rules and regulations inconsistent with the
7 provisions of this Act shall be deemed modified or repealed
8 accordingly.

9 SEC. 3. Within thirty (30) days from the effectivity
10 of this Act, the Chief of the Philippine National Police shall issue
11 the necessary rules and regulations for the effective implementation
12 of this Act.

13 SEC. 4. This Act shall take effect fifteen (15) days after
14 its full publication in a newspaper of general circulation.
