The Committees on Local government; and electoral Reforms and People's Participation, to which were referred House Bill No. 990, introduced by Representative Joaquin M. Chipeco, Jr., entitled:





AN ACT SEPARATING THE CITY OF CALAMBA FROM THE SECOND
LEGISLATIVE DISTRICT OF THE PROVINCE OF LAGUNA TO
CONSTITUTE THE LONE LEGISLATIVE DISTRICT OF THE
CITY OF CALAMBA

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Lone Legislative District.* - The City of Calamba is
2 hereby separated from the Second Legislative District of the Province of
3 Laguna to constitute the Lone Legislative District of the City of Calamba,
4 which shall commence in the next national election after the effectivity of this
5 Act.

6 SEC. 2. *Incumbent Representative.* - The incumbent Representative of
7 the present Second Legislative District of the Province of Laguna shall
8 continue to represent the said district until the expiration of his term of office.

9 SEC. 3. *Rules and Regulations.* - The Commission on Elections shall
10 issue the necessary rules and regulations to implement this Act within thirty
11 (30) days after its effectivity.

1 **SEC. 4. *Repealing Clause.*** – All laws, rules and regulations which are
2 inconsistent with this Act are hereby repealed, amended or modified
3 accordingly.

4 **SEC. 5. *Effectivity.*** – This Act shall take effect fifteen (15) days after
5 its publication in at least two (2) newspapers of general circulation.
