AN ACT UPGRADING THE DR. PAULINO J. GARCIA
MEMORIAL RESEARCH AND MEDICAL CENTER
EXTENSION HOSPITAL IN THE MUNICIPALITY OF
TALAVERA, PROVINCE OF NUEVA ECIJA, TO A LEVEL II
HOSPITAL AND INCREASING ITS BED CAPACITY FROM
FIFTY (50) TO ONE HUNDRED (100) BEDS TO BE NOW
KNOWN AS THE TALAVERA GENERAL HOSPITAL, AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The Dr. Paulino J. Garcia Memorial Research
2 and Medical Center Extension Hospital in the Municipality of
3 Talavera, Province of Nueva Ecija, is hereby upgraded into a
4 Level II Hospital to be now known as the Talavera General
5 Hospital.

6 The authorized bed capacity of the Talavera General Hospital
7 is hereby increased from fifty (50) to one hundred (100) beds.

8 The Secretary of the Department of Health (DOH) shall
9 implement the increase in bed capacity of the Talavera General

1 Hospital within a period of five (5) years from the approval of this
2 Act.

3 SEC. 2. The existing hospital facilities and professional
4 health care services of the Talavera General Hospital are hereby
5 upgraded to conform with and be commensurate to the increase in
6 bed capacity. The number of medical personnel shall be
7 correspondingly increased.

8 SEC. 3. The Secretary of Health shall immediately include in
9 the Department's programs the implementation of this Act, the
10 funding of which shall be included in the annual General
11 Appropriations Act.

12 SEC. 4. Republic Act No. 8527, increasing the bed capacity of
13 Dr. Paulino J. Garcia Memorial Research and Medical Center
14 Extension Hospital, is hereby repealed. All other laws, decrees,
15 orders, issuances, rules and regulations and parts thereof which are
16 inconsistent with the provisions of this Act are hereby repealed.

17 SEC. 5. Within sixty (60) days after the approval of this Act,
18 the DOH shall promulgate the necessary rules and regulations for
19 the effective implementation of this Act.

20 SEC. 6. This Act shall take effect fifteen (15) days after its
21 publication in the *Official Gazette* or in a newspaper of general
22 circulation.
