

AN ACT ESTABLISHING A ONE HUNDRED (100)-BED
CAPACITY HOSPITAL IN BARANGAY HABAY 2 IN THE
CITY OF BACOR, PROVINCE OF CAVITE TO BE
KNOWN AS THE BACOR DISTRICT HOSPITAL, AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established, under the technical
2 supervision of the Department of Health, a one hundred (100)-bed
3 capacity hospital in Barangay Habay 2, City of Bacor, Province of
4 Cavite to be known as the Bacor District Hospital.

5 SEC. 2. The Provincial Government of Cavite shall provide
6 funding for the establishment of the Bacor District Hospital. The
7 Secretary of Health shall include in the Department's subsidy
8 program, support for the capital outlay requirements of the said
9 hospital.

1 SEC. 3. This Act shall take effect fifteen (15) days after its
2 publication in the *Official Gazette* or in a newspaper of general
3 circulation.
