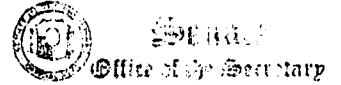





AN ACT PROVIDING FOR THE ESTABLISHMENT OF A
DISTRICT HOSPITAL IN THE MUNICIPALITY OF
SANTA ELENA, PROVINCE OF CAMARINES NORTE AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established, under the
2 supervision of the Department of Health, a district hospital in the
3 Municipality of Santa Elena, Province of Camarines Norte to be
4 known as the Santa Elena District Hospital.

5 SEC. 2. The Department of Health shall issue the necessary
6 rules and regulations for the effective implementation of this Act.

7 SEC. 3. The Provincial Government of Camarines Norte
8 shall provide funding for the establishment, operation and
9 maintenance of the Santa Elena District Hospital. The Secretary of
10 Health shall include in the Department's subsidy program, support
11 for the capital outlay of the said district hospital.

1 SEC. 4. This Act shall take effect fifteen (15) days after
2 its publication in the *Official Gazette* or in a newspaper of general
3 circulation.
