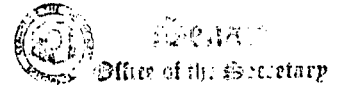

Recommending the approval of House Bill No. 6740 with amendments.

Sponsor : Senator Joseph Victor G. Ejercito

Mr. President:

The Committees on Health and Demography, and Finance, to which was referred House Bill No. 6740, introduced by Representatives Dalipe, Lobregat, Tambunting and Nograles (K.A.), entitled:

"AN ACT

UPGRADING THE LABUAN PUBLIC HOSPITAL IN ZAMBOANGA CITY INTO A LEVEL II HOSPITAL TO BE KNOWN AS THE LABUAN GENERAL HOSPITAL, INCREASING ITS BED CAPACITY FOR GENERAL CARE SERVICES TO ONE HUNDRED (100), AND APPROPRIATING FUNDS THEREFOR"

have considered the same and have the honor to report back to the Senate with the recommendation that the attached House Bill No. 6740, be approved with the following amendments:

1. On Page 1, line 2, delete the word "City" and replace it with "**DEL SUR**".
2. On Page 1, line 8, after the word "hereof.", insert a sentence that states:
"THE HOSPITAL SHALL BE TRANSFERRED TO THE ZAMBOANGA FREEPORT AND ECONOMIC ZONE."

Thus, Section 2, as amended, shall now read as follows:

"SEC. 2. The existing hospital facilities and professional health care services of the Labuan General Hospital are hereby upgraded

to conform with and be commensurate to the increase in its bed capacity as provided in Section 1 hereof. **THE HOSPITAL SHALL BE TRANSFERRED TO THE ZAMBOANGA FREEPORT AND ECONOMIC ZONE.**"

3. On Page 2, Line 6, insert a new section that reads:

"SEC. 6. ALL LAWS, DECREES, ORDERS, ISSUANCES, RULES AND REGULATIONS OR PARTS THEREOF INCONSISTENT WITH THE PROVISIONS OF THIS ACT ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY."


Renumber the succeeding section accordingly.

4. On Page 1, Title of the bill, delete the word "CITY" and replace it with the phrase "**DEL SUR**". The title of the bill now reads:

**"AN ACT
UPGRADING THE LABUAN PUBLIC HOSPITAL IN
ZAMBOANGA DEL SUR INTO A LEVEL II HOSPITAL TO BE
KNOWN AS THE LABUAN GENERAL HOSPITAL,
INCREASING ITS BED CAPACITY FOR GENERAL CARE
SERVICES TO ONE HUNDRED (100), AND
APPROPRIATING FUNDS THEREFOR"**

BY REPRESENTATIVES DALIPE, LOBREGAT, TAMBUNTING AND
NOGRALES (K.A.), PER COMMITTEE REPORT NO. 496

AN ACT UPGRADING THE LABUAN PUBLIC HOSPITAL IN
ZAMBOANGA CITY INTO A LEVEL II HOSPITAL TO BE
KNOWN AS THE LABUAN GENERAL HOSPITAL,
INCREASING ITS BED CAPACITY FOR GENERAL CARE
SERVICES TO ONE HUNDRED (100), AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

- 1 SECTION 1. The Labuan Public Hospital located in
2 Zamboanga City is hereby upgraded into a Level II Hospital to be
3 known as the Labuan General Hospital and its authorized bed
4 capacity for general care services increased to one hundred (100).
5 SEC. 2. The existing hospital facilities and professional
6 health care services of the Labuan General Hospital are hereby
7 upgraded to conform with and be commensurate to the increase in
8 its bed capacity as provided in Section 1 hereof.
9 SEC. 3. The Department of Health, shall, in coordination
10 with the Department of Budget and Management and the Labuan

1 General Hospital, determine the additional staff plantilla positions
2 to be created pursuant to this Act.

3 SEC. 4. The increase in bed capacity of the Labuan General
4 Hospital to one hundred (100) beds for general care services shall be
5 implemented for a period of not more than four (4) years from the
6 approval of this Act.

7 SEC. 5. The Secretary of Health shall immediately include in
8 the Department's programs the implementation of this Act, the
9 funding of which shall be included in the annual General
10 Appropriations Act.

11 SEC. 6. This Act shall take effect fifteen (15) days after its
12 publication in the *Official Gazette* or in a newspaper of general
13 circulation.
