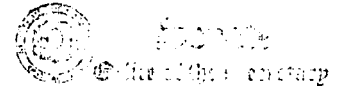

AN ACT
ESTABLISHING A MULTI-SPECIES MARINE HATCHERY IN THE
MUNICIPALITY OF PASACAO, PROVINCE OF CAMARINES SUR AND
APPROPRIATING FUNDS THEREFOR

EXPLANATORY NOTE

Reports have it that over seventy percent (70%) of the world's fish stocks are fully exploited or are already overfished. Overfishing is a major concern globally, with experts issuing warnings that if sustainable fishing is not practiced and oceans are not given time to recover, they could become 'virtual deserts' by 2050 or barely 33 years from now¹.

Still, there is an ever-increasing demand for high-value marine species in both local and export markets. As fish stocks diminish, aquaculture is seen as way to satisfy the world's growing appetite for fish and at the same time allow wild fish species to multiply their numbers.

In the Philippines, aquaculture is a growing industry that provides livelihood to hundreds of thousands and their number is consistently on the rise. The potential of the sector in contributing significantly to the economic development of the country should be recognized and maximized, especially that many of our traditional fishing grounds are getting overfished.

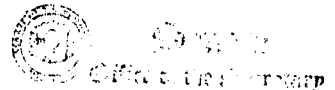

AN ACT
ESTABLISHING A MULTI-SPECIES MARINE HATCHERY IN THE
MUNICIPALITY OF PASACAO, PROVINCE OF CAMARINES SUR AND
APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 Section 1. There shall be established, under the supervision of the Bureau of
2 Fisheries and Aquatic Resources of the Department of Agriculture (BFAR-DA), a
3 multi-species marine hatchery in the Municipality of Pasacao, Province of Camarines
4 Sur.

5 Sec. 2. The BFAR-DA shall, within two (2) years after the construction of the
6 multi-species marine hatchery, transfer the management of the same to the local
7 government unit concerned through a memorandum of agreement. It shall
8 implement a training and phasing-in program for local government personnel on the
9 management and operation of the hatchery.

10 Sec. 3. The Secretary of Agriculture shall include in the Department's
11 programs the establishment of the multi-species marine hatchery in the Municipality
12 of Pasacao, Province of Camarines Sur, the funding of which shall be included in the
13 annual General Appropriations Act. The local government unit concerned shall set

14 aside funds from any available local revenue deemed appropriate for the
15 operationalization of the hatchery.

16
17 Sec. 4. Within sixty (60) days from the passage of this Act, the Secretary of
18 Agriculture shall issue the rules and regulations on the supervision and monitoring,
19 and the transfer or withdrawal by the BFAR of the multi-species marine hatchery.

20 Sec. 5. This Act shall take effect fifteen (15) days after its publication in the
21 Official Gazette or in a newspaper of general circulation.
