

EXPLANATORY NOTE

Section 16, Article III of the 1987 Constitution states that "All persons shall have the right to a speedy disposition of their cases before all judicial, quasi, or administrative bodies", thus, this measure seeks to create additional branches of the Regional Trial Court (RTC) in the Province of Zamboanga Del Norte stationed in the Municipality of Liloy from the Ninth Judicial Region.

By the virtue of Batas Pambansa Bilang 129 or The Judiciary Reorganization Act of 1980, the Third District of Zamboanga currently has two branches of RTC stationed in the municipalities of Liloy and Siocon. To decongest court dockets of voluminous cases filed and to provide a speedy trial, the establishment and creation of additional branches of RTC is strongly urged. This is also to address the needs of our growing populace and the delay in resolution of cases pending before said courts.

In view of the foregoing, the approval of this bill is earnestly sought.
