



AN ACT SEPARATING THE DON FELIX SERRA NATIONAL  
HIGH SCHOOL - LOMBOYAN EXTENSION IN  
BARANGAY LOMBOYAN, MUNICIPALITY OF SAN  
JOAQUIN, PROVINCE OF ILOILO FROM THE DON FELIX  
SERRA NATIONAL HIGH SCHOOL, CONVERTING IT  
INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO  
BE KNOWN AS STA. ANA NATIONAL HIGH SCHOOL,  
AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1           SECTION 1. The Don Felix Serra National High School -  
2 Lomboyan Extension in Barangay Lomboyan, Municipality of San  
3 Joaquin, Province of Iloilo is hereby separated from the Don Felix  
4 Serra National High School and converted into an independent  
5 national high school to be known as Sta. Ana National High School.

6           SEC. 2. All personnel, assets, liabilities, and records  
7 of the Don Felix Serra National High School - Lomboyan Extension  
8 are hereby transferred to and absorbed by the Sta. Ana National  
9 High School.

1           SEC. 3. The Secretary of Education shall immediately include  
2 in the Department's program the operationalization of the Sta. Ana  
3 National High School, the initial funding of which shall be charged  
4 against the current year's appropriation of the ~~Don~~ Felix Serra  
5 National High School - Lomboyán Extension. Thereafter,  
6 the amount necessary for the continued operation of the school  
7 shall be included in the annual General Appropriations Act.

8           SEC. 4. The Secretary of Education shall formulate the rules  
9 and regulations necessary to carry out the purpose of this Act  
10 within one hundred twenty (120) days after its effectivity.

11           SEC. 5. This Act shall take effect fifteen (15) days after  
12 its publication in the *Official Gazette* or in a newspaper of general  
13 circulation.
