

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The name of Tawantawan Elementary School
2 in Barangay Tawantawan, Baguio District, Davao City is hereby
3 changed to Rosalia "Aglay" Ayag Elementary School.

4 SEC. 2. The main campus of the Rosalia "Aglay" Ayag
5 Elementary School shall continue to remain in its present location
6 in Barangay Tawantawan, Baguio District, Davao City.

7 SEC. 3. This Act shall take effect fifteen (15) days after
8 its publication in the *Official Gazette* or in any newspaper
9 of general circulation.
