



AN ACT CONVERTING THE BAYOG NATIONAL HIGH SCHOOL IN BARANGAY KAHAYAGAN, MUNICIPALITY OF BAYOG, PROVINCE OF ZAMBOANGA DEL SUR INTO A NATIONAL TECHNICAL - VOCATIONAL HIGH SCHOOL TO BE KNOWN AS BAYOG NATIONAL TECHNICAL - VOCATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Bayog National High School in Barangay
2 Kahayagan, Municipality of Bayog, Province of Zamboanga del Sur
3 is hereby converted into a national technical-vocational high
4 school to be known as Bayog National Technical-Vocational High
5 School.

6 SEC. 2. All personnel, assets, liabilities, and records of
7 the Bayog National High School are hereby transferred to and
8 absorbed by the Bayog National Technical-Vocational High
9 School.

1 SEC. 3. The Secretary of Education shall immediately include
2 in the Department's program the operationalization of the Bayog
3 National Technical-Vocational High School, the funding of which
4 shall be included in the annual General Appropriations Act.

5 SEC. 4. The Secretary of Education shall formulate the rules
6 and regulations implementing the provisions of this Act within
7 ninety (90) days after its effectivity.

8 SEC. 5. This Act shall take effect fifteen (15) days after its
9 publication in the *Official Gazette* or in any newspaper of general
10 circulation.
