AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE (LTO)
EXTENSION OFFICE LOCATED IN LAPU-LAPU CITY,
PROVINCE OF CEBU, INTO A REGULAR LTO DISTRICT
OFFICE AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. The Land Transportation Office (LTO) Extension Office located in Lapu-Lapu City, Province of Cebu, is hereby converted into a regular LTO District Office.
  - SEC. 2. The Secretary of the Department of Transportation (DOTr) shall immediately include in the Department's program the operationalization of the LTO Extension Office in Lapu-Lapu City, the funding of which shall be included in the annual General Appropriations Act.
- SEC. 3. The Secretary of the DOTr shall issue the necessary rules and regulations within ninety (90) days from the effectivity of this Act.

- SEC. 4. This Act shall take effect fifteen (15) days after its publication
- 2 in the Official Gazette or in a newspaper of general circulation. Approved,
