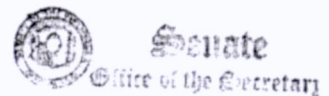





BY REPRESENTATIVES SALIMBANGON, SARMIENTO (C.) AND

AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE –
MEDELLIN EXTENSION OFFICE INTO A REGULAR DISTRICT
OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The existing Land Transportation Office – Medellin
2 Extension Office located in the Municipality of Medellin, Province of Cebu is
3 hereby converted into a Regular Land Transportation Office (LTO) District
4 Office.

5 SEC. 2. The Secretary of the Department of Transportation shall issue
6 rules and regulations necessary for the effective implementation of this Act.

7 SEC. 3. The Secretary of Transportation shall immediately include in
8 the Department's programs the operationalization of a regular district office in
9 the Municipality of Medellin, Province of Cebu, the initial funding of which
10 shall be charged against the current year's appropriations of the Land
11 Transportation Office – Medellin Extension Office. Thereafter, such sums as
12 may be necessary for the continued operation of the LTO District Office shall
13 be included in the annual General Appropriations Act.

14 SEC. 4. This Act shall take effect fifteen (15) days after its publication
15 in the *Official Gazette* or in a newspaper of general circulation.

Approved,
