AN ACT ESTABLISHING AN EXTENSION OFFICE OF THE LAND
TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF
NARRA, PROVINCE OF PALAWAN AND APPROPRIATING
FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established, under the supervision of the
2 Land Transportation Office (LTO) Palawan District Office, an Extension
3 Office of the LTO in the Municipality of Narra, Province of Palawan.

4 SEC. 2. The Secretary of the Department of Transportation shall
5 immediately include in the Department's program the operationalization of the
6 LTO Extension Office in the Municipality of Narra, Province of Palawan,
7 the funding of which shall be included in the annual General Appropriations
8 Act.

9 SEC. 3. The Secretary of the Department of Transportation shall issue
10 the necessary rules and regulations within ninety (90) days from the effectivity
11 of this Act.

1 SEC. 4. This Act shall take effect fifteen (15) days after its publication
2 in the *Official Gazette* or in a newspaper of general circulation.
