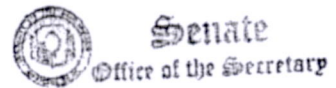



AN ACT ESTABLISHING A LAND TRANSPORTATION OFFICE (LTO)
DISTRICT OFFICE IN THE CITY OF SIPALAY, PROVINCE
OF NEGROS OCCIDENTAL AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established a district office of the Land
2 Transportation Office (LTO) in the City of Sipalay, Province of Negros
3 Occidental.

4 SEC. 2. The Secretary of the Department of Transportation (DOTr)
5 shall immediately include in the Department's programs the operationalization
6 of the LTO District Office in the City of Sipalay, Province of Negros
7 Occidental, the funding of which shall be included in the annual General
8 Appropriations Act.

9 SEC. 3. The Secretary of the DOTr shall issue rules and regulations
10 necessary for the effective implementation of this Act within sixty (60) days
11 from the effectivity of this Act.

- 1 SEC. 4. This Act shall take effect fifteen (15) days after its publication
- 2 in the *Official Gazette* or in a newspaper of general circulation.
