BY REPRESENTATIVE ROBES, PER COMMITTEE REPORT NO. 792

AN ACT DIVIDING BARANGAY MUZON IN THE CITY OF SAN JOSE DEL MONTE, PROVINCE OF BULACAN INTO FOUR (4) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY MUZON PROPER, BARANGAY MUZON EAST, BARANGAY MUZON WEST AND BARANGAY MUZON SOUTH

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Division of Muzon.* – Barangay Muzon in the
2 City of San Jose del Monte, Province of Bulacan is hereby divided
3 into four (4) distinct and independent barangays to be known as
4 Barangay Muzon Proper, Barangay Muzon East, Barangay Muzon
5 West and Barangay Muzon South.

6 SEC. 2. *Territorial Boundaries.* – The territorial boundaries
7 of each barangay created in the immediately preceding section shall
8 be as follows:

- 9 (1) Barangay Muzon Proper
10 "Bounded on the North by Muzon East;
11 On the East by Poblacion I;
12 On the Southeast (SE) by Muzon South;

1 On the Northeast (NE) by Barangay Gaya-gaya; and
2 On the Southwest (SW) by Sta. Maria, Bulacan”
3 Containing an area of 315.15 hectares, more or less.

4 (2) Barangay Muzon East

5 “Bounded on the North by Dulong Bayan;
6 On the East by Poblacion;
7 On the Southeast (SE) by Muzon Proper; and
8 On the Southwest (SW) by Muzon West”
9 Containing an area of 256.88 hectares, more or less.

10 (3) Barangay Muzon West

11 “Bounded on the Northeast (NE) by Muzon East;
12 On the East by Muzon Proper;
13 On the Southwest (SW) by Sta. Maria, Bulacan; and
14 On the Northwest (NW) by Sta. Maria, Bulacan”
15 Containing an area of 194.74 hectares, more or less.

16 (4) Barangay Muzon South

17 “Bounded on the North by Muzon Proper;
18 On the East by Caloocan City;
19 On the Southeast (SE) by Caloocan City; and
20 On the Southwest (SW) by Muzon Proper, Caloocan City
21 and Marilao, Bulacan”
22 Containing an area of 148.88 hectares, more or less.

23 SEC. 3. *Conduct and Supervision of Plebiscite.* – The
24 Commission on Elections (COMELEC) shall conduct and supervise
25 the plebiscite to be held in Barangay Muzon in the City of San Jose
26 del Monte, Province of Bulacan within thirty (30) days from the
27 effectivity of this Act.

1 The expenses for such plebiscite shall be borne by the City of
2 San Jose del Monte.

3 SEC. 4. *Incumbent Barangay Officials.* – The incumbent
4 barangay officials of Barangay Muzon shall continue to hold office
5 and administer Barangays Muzon Proper, Muzon East, Muzon West
6 and Muzon South until such time that the officials of the newly
7 created barangays have been duly elected and qualified.

8 SEC. 5. *Public Infrastructure and Facilities.* – All public
9 infrastructure and facilities for public use existing therein at the
10 time of the approval of this Act are hereby transferred without cost
11 or compensation to and shall be administered by the new
12 barangays.

13 SEC. 6. *Internal Revenue Allotment Shares.* – All barangays
14 herein created shall be entitled to Internal Revenue Allotment (IRA)
15 shares pursuant to Section 285 of Republic Act No. 7160, as
16 amended, otherwise known as the “Local Government Code of
17 1991”.

18 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)
19 days after its publication in the *Official Gazette* or in any newspaper
20 of general circulation.
