

AN ACT UPGRADING THE SUB-DISTRICT ENGINEERING OFFICE
LOCATED IN THE MUNICIPALITY OF CARMONA, PROVINCE
OF CAVITE INTO A REGULAR DISTRICT ENGINEERING
OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The sub-district engineering office located in the
2 Municipality of Carmona, Province of Cavite, is hereby upgraded into a
3 regular district engineering office to be known as the Cavite Third District
4 Engineering Office.

5 SEC. 2. The district engineering office shall serve the municipalities of
6 Carmona, Silang and General Mariano Alvarez of the Fifth Legislative District
7 of the Province of Cavite and the cities of Bacoor and Dasmariñas of the
8 Second and Fourth Legislative Districts of the Province of Cavite,
9 respectively.

10 SEC. 3. The Secretary of Public Works and Highways shall include in
11 the Department's program the operationalization of the Cavite Third District
12 Engineering Office in the Province of Cavite, the funding of which shall be
13 included in the annual General Appropriations Act.

- 1 SEC. 4. This Act shall take effect fifteen (15) days after its publication
- 2 in the *Official Gazette* or in a newspaper of general circulation.
