AN ACT CONVERTING THE MIDSAYAP EXTENSION OFFICE OF THE LAND TRANSPORTATION OFFICE (LTO) LOCATED IN MIDSAYAP, NORTH COTABATO INTO A REGULAR LTO DISTRICT OFFICE AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The Midsayap Extension Office of the Land Transportation Office (LTO) located in Midsayap, North Cotabato is 2 hereby converted into a regular LTO district office and thereafter 3 shall be referred to as the Midsayap LTO District Office. 4

SEC. 2. The Secretary of Transportation shall immediately

include in the Department's program the operationalization of the 6 Midsayap LTO District Office, the initial funding of which shall be charged against the current year's appropriations of the existing 8 Midsayap LTO Extension Office in Midsayap, North Cotabato. Thereafter, such sums as may be necessary for the continued 10

- operation of the Midsayap LTO District Office shall be included in the annual General Appropriations Act.
- SEC. 3. The Secretary of Transportation shall issue the necessary rules and regulations for the effective implementation of this Act.
- SEC. 4. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
