AN ACT ESTABLISHING AN EXTENSION OFFICE OF THE LAND
TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY
OF BROOKE'S POINT, PROVINCE OF PALAWAN AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established, under the supervision of the
2 Land Transportation Office (LTO) Palawan District Office, an Extension
3 Office of the LTO in the Municipality of Brooke's Point, Province of Palawan.

4 SEC. 2. The Secretary of Transportation shall immediately include in
5 the Department's programs the operationalization of the LTO Extension
6 Office in the Municipality of Brooke's Point, Province of Palawan, the
7 funding of which shall be included in the annual General Appropriations Act.

8 SEC. 3. The Chairperson of the LTO shall issue such rules and
9 regulations as may be necessary to carry out the purpose of this Act.

10 SEC. 4. This Act shall take effect fifteen (15) days after its publication
11 in the *Official Gazette* or in a newspaper of general circulation.
