

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established a Land Transportation Office
2 (LTO) District Office in the City of Valencia, Province of Bukidnon.

3 SEC. 2. The Secretary of Transportation shall immediately include in
4 the Department's program the operationalization of the LTO District Office in
5 the City of Valencia, Province of Bukidnon, the funding of which shall be
6 included in the annual General Appropriations Act.

7 SEC. 3. The Secretary of Transportation shall issue the necessary rules
8 and regulations for the effective implementation of this Act.

9 SEC. 4. This Act shall take effect fifteen (15) days after its publication
10 in the *Official Gazette* or in a newspaper of general circulation.

EXPLANATORY NOTE

**AN ACT
ESTABLISHING A LAND TRANSPORT OFFICE (LTO) IN THE CITY OF VALENCIA,
PROVINCE OF BUKIDNON AND APPROPRIATING FUNDS THEREFOR**

This bill is geared towards the transformation of the Land Transportation Office (LTO) Mobile Office in Valencia, Province of Bukidnon into a distinct LTO District Office.

The LTO of Bukidnon, with its efforts to decongest its office in Malaybalay, has institutionalized the LTO Mobile Office in Valencia City.

The current function of the LTO Mobile Office is focused only on manual renewal of registration. Therefore, vehicle owners and motorists coming from the southern part of Bukidnon are still required to travel to the LTO District Office in Malaybalay for other services such as computerized renewal of registration, application and renewal of license, and payment for traffic violations.

Hence, the LTO District Office at Malaybalay City is still very much congested and cannot effectively serve the needs of the people. The establishment of a proper LTO District Office in Valencia City will address these problems and efficiently deliver the services needed by these constituents.

Thus, the passage of this bill is earnestly sought.

**AN ACT
ESTABLISHING A LAND TRANSPORT OFFICE (LTO) IN THE CITY OF VALENCIA,
PROVINCE OF BUKIDNON AND APPROPRIATING FUNDS THEREFOR**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** There is hereby established a separate Land Transportation Office
2 (LTO) in the City of Valencia, Province of Bukidnon.

3 **SECTION 2.** The Chairperson of the Land Transportation Office (LTO) shall
4 immediately include in the Office's program the operationalization of the Land
5 Transportation Office in the City of Valencia, Province of Bukidnon, the funding of which
6 shall be included in the annual General Appropriations Act.

7 **SECTION 3.** The Chairperson of the Land Transportation Office shall issue such rules
8 and regulations as may be necessary to carry out the purpose of this act.

9 **SECTION. 4.** This act shall take effect 15 days after its publication in the Official
10 Gazette.
