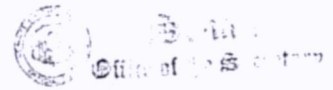





AN ACT
GRANTING PHILIPPINE CITIZENSHIP TO BRUCE DONALD MCTAVISH

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** Bruce Donald McTavish is hereby granted Philippine citizenship with all
2 the rights, privileges and prerogatives appurtenant thereto. Upon taking and registration of
3 the oath of allegiance to the Republic of the Philippines, Bruce McTavish shall enter the full
4 enjoyment of the Philippine citizenship.

5
6 **Sec. 2. Repealing Clause.** – All laws, decrees, orders, rules and regulations or
7 other issuances or parts thereof inconsistent with the provisions of this Act are hereby
8 repealed or modified accordingly.

9
10 **Sec. 3. Effectivity.** – This Act shall take effect fifteen (15) days following the
11 completion of its publication either in the Official Gazette or in a newspaper of general
12 circulation in the Philippines.

AN ACT GRANTING PHILIPPINE CITIZENSHIP TO BRUCE
DONALD MCTAVISH

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. Mr. Bruce Donald McTavish is hereby granted
2 Philippine citizenship with all the rights, privileges and
3 prerogatives, and is likewise vested with the duties and obligations
4 appurtenant thereto.

5 SEC. 2. Mr. Bruce Donald McTavish shall take the Oath
6 of Allegiance to the Republic of the Philippines before an officer
7 duly authorized to administer the same. The Oath of Allegiance
8 shall be registered with the Bureau of Immigration.

9 SEC. 3. Upon registration of the Oath of Allegiance,
10 the Bureau of Immigration shall issue a Certificate of
11 Naturalization to Mr. McTavish who shall thereupon enter
12 into the full enjoyment of Philippine citizenship.

1 SEC. 4. This Act shall take effect fifteen (15) days after
2 its publication in the *Official Gazette* or in any newspaper
3 of general circulation.
