

	AN ACT GRANTING PHILIPPINE CITIZENSHIP TO MAYLEEN TING
	Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:
1	SECTION 1. Ms. Mayleen Ting is hereby granted Philippine
2	citizenship with all the rights, privileges and prerogatives, as well
3	as the duties and obligations appurtenant thereto.
4	SEC. 2. Ms. Mayleen Ting shall take the Oath of Allegiance
5	to the Republic of the Philippines before an officer duly authorized
6	to administer the same. The Oath of Allegiance shall be registered
7	with the Bureau of Immigration.
8	SEC. 3. Upon registration of the Oath of Allegiance, the
9	Bureau of Immigration shall issue a Certificate of Naturalization to
10	Ms. Mayleen Ting who shall thereupon enter into the full enjoyment
11	of Philippine citizenship.
